# "Licensing Strategy of Japanese Firms"

### Summary

The usual approach to inventions and patents is led by a science and technology perspective. However, almost all actors who are applying for patents on inventions are definitely doing so with a business perspective in mind. Under what circumstances should enterprises be innovative and file their inventions to get patents? Inventions are traditionally regarded as mere fruits of R&D as "inventions for technological strategy." In contrast to these, inventions resulting from other factors and contexts are collectively defined as "inventions for patent strategy". Then, a simple analysis method is proposed to determine which inventions motivated by technological strategy. We will argue that Japanese firms' behavior is better explained as a rationally perspective of "licensing business", which is a completely different behaviour than that of the approach of a science and technology perspective.

Dr. Nobuo Takahashi, Professor of Management at the Graduate School of Economics, University of Tokyo, received his Ph.D. in Socio-Economic Planning from the University of Tsukuba in 1987. His thesis is entitled: "Design of Organizations and Statistical Decisions". His first book, *Design of Adaptive Organizations* (Springer-Verlag, 1987) received the Takamiya Award from the Academic Association for Organizational Science. He was a Visiting Research Fellow at the Board of Audit, Japan, 1998-2000. He received the Transportation Book Award from Kōtsū Kyōryoku Kai in 2001 for his 『鉄道経営と資金調達』 (*Railway Management and Financing Schemes*). He is author of the bestseller book of the year 2004: 『虚妄の成果主義』 (*Performance-Based Pay System of False and Fancy*). He is also author of various papers published in *Human Relations, Behavioral Science, European Journal of Operational Research*, *Omega...*
